


# MMB Member Survey Responses - March 2021

## Vaccination Status?




- I am fully vaccinated

## Do you plan to get vaccine?




- Yes

I feel masks and bell covers should be worn during rehearsals and performances. There are blow hole masks available for Brass Players and special masks with a slit cut in them for woodwind players. All percussionists should wear masks.

Masks should continue to be worn. Bell covers for the instruments, blow hole masks for Brass Players/masks with slit cut in them for woodwind players. Percussionists wear masks.

Following CDC guidelines, I would recommend a slow transition to full participation in band rehearsal. In May, allow only vaccinated members and continue to add new vaccinated members each month until August when we could open up for full participation.

Do not return until it is 100% safe. June might be a little early.

I will hopefully be traveling over the summer to visit my grandchildren.
